5.3. Advice for firefighters

SECTION 7: Handling and storage

7.1. Precautions for safe handling

Safe handling of the gas receptacle

Safe use of the product

: Containers, which contain or have contained flammable or explosive substances, must not be inerted with liquid carbon dioxide. Potential production of solid CO2 particles must be ruled out. In order to rule out potential electrostatic discharge production, the system must be adequately grounded.

Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt.

Do not smoke while handling product.

Avoid suck back of water, acid and alkalis.

Only experienced and properly instructed persons should handle gases under pressure. Ensure the complete gas system was (or is regularily) checked for leaks before use.

When moving cylinders, even for short distances, use a cart (trolley, hand truck, etc.) designed to transport cylinders.

Suck back of water into the container must be prevented.

Open valve slowly to avoid pressure shock.
